

Terms & Conditions

Wear Referrals Discount Offer

1. Wear Referrals ("we", "us", and "our") is a business unit of Linnaeus Veterinary Limited (Company Number: 10790375) ("LVL") with a registered office at Friars Gate, 1011 Stratford Road, Shirley, West Midlands, B90 4BN and the promoter of the Offer.
2. We are offering a 10% discount on all services provided excluding VAT ("Offer"). The Offer is open to the employees of any First Opinion Veterinary Practice, which are not part of LVL (the "Participant", "you", and "your"), that makes a referral to Wear Referrals between 9:00 am on 19th October 2020 (the "Start Date") and 9:00 am on 19th October 2021 (the "Closing Date"). Only referrals received between the Start Date and Closing Date will be eligible for the Offer and those received outside these timeframes will not be considered.
